- **The OneHealthPort single sign-on security service** still offers *free logins* to provider practices accessing participating secure health plan and healthcare websites. The HIE is the next-generation solution for system to system data exchange.

Imagine health care having the same low cost, ubiquitous, easy-to-access electronic information exchange you take for granted in financial services, travel, smart-phones and so many other areas. That's the promise of Health Information Exchange (HIE). The first step toward this vision for Washington state is underway now, with the OneHealthPort HIE.

With Federal funding, OneHealthPort and the Health Care Authority have partnered to deploy Washington's statewide HIE, now available to health organizations in Washington state at reduced "early adopter" rates.

WHY CONNECT TO THE ONEHEALTHPORT HIE?

The HIE allows you to connect your business and clinical information systems *once* to a single central hub, and seamlessly exchange data with all your trading partners that are also connected.

The HIE can help your organization:

- Get business and clinical information to and from key trading partners like health plans, your referral network and public agencies in a less costly, complex, and risky way than other solutions
- Qualify for the Meaningful Use incentive payments, which requires electronic exchange of health information
- Work with Accountable Care Organizations, which involves sharing data to better coordinate patient care and improve outcomes

WHAT DATA CAN BE EXCHANGED?

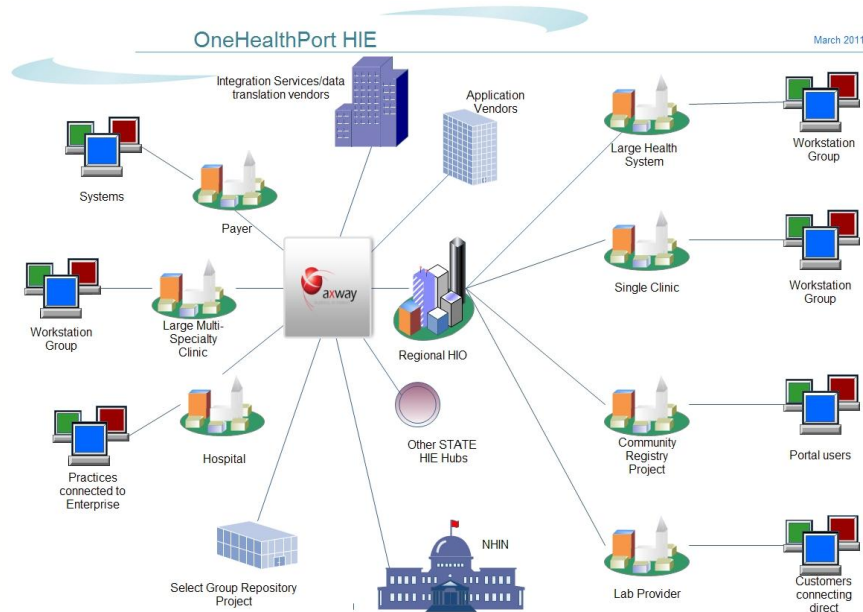
In the long term, trading partners will be able to use the HIE for all their data exchange needs. In the short term, the HIE will prioritize exchange of eight high value data sets. These initial data sets (eligibility, immunizations, lab, radiology, ADT, CCD, ePrescribing, and CMS quality reports) support the Meaningful Use program, and also meet critical business and clinical needs in the marketplace.



(CCD = Continuity of Care Document; ADT = Admission, Discharge, Transfer patient demographic data)

HOW DOES THE ONEHEALTHPORT HIE WORK?

The OneHealthPort HIE is powered by Axway technology, which lies at the heart of many successful information exchanges in health care and in the larger marketplace. Axway's state-of-the-art engine allows you to connect your business and clinical information systems *once* to a central hub, map your data to the community standard and seamlessly exchange data with all your trading partners that are also connected to the hub. Most trading partners will connect directly to the HIE hub. Local HIEs can also connect to the hub allowing their trading partners to enjoy the same benefits.



HOW MUCH DOES THE HIE COST?

1. **Set Up Fee**—A one-time software license will be charged to connect your system to the HIE hub. For early adopters *this fee is waived* thanks to subsidies from ARRA.
2. **Mapping Costs**—Each trading partner will map their data to the community standard transaction. This cost will likely range from \$500 to \$5,000 for the most complex cases.
3. **Annual Subscription**—The annual subscription fee includes unlimited usage with no additional transaction fees.
